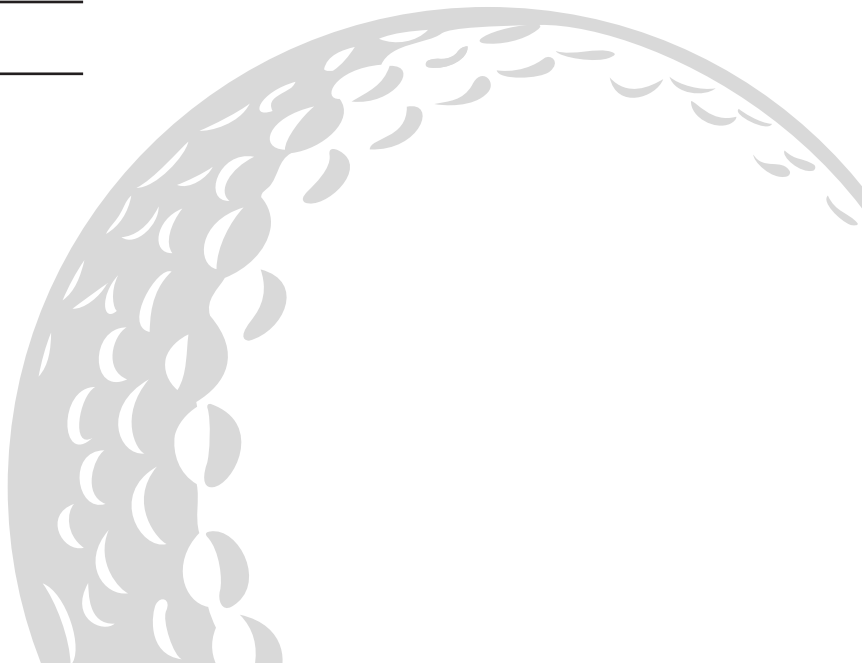

# Golfing in Brittany Booking Conditions

## Provision of your Golf Package

We will arrange for the provision of all parts of the inclusive golf package as confirmed to you. There is no holiday booked until you have received a confirmation invoice. An invoice will normally only be sent after a deposit is received. This invoice acts as our confirmation of the booking conditions and your golf package is then secured.

## Price Guarantee

The price of all quotations is guaranteed for 30 days. The company seeks every opportunity to avoid the imposition of surcharges but this is not always possible. The company, therefore, reserves the right to impose a surcharge if the exchange rate varies by more than 5% between the time of the quotation and receipt of the final payment.

## Your Commitment to us

The full amount of the holiday must be paid by the due date on the invoice. Failure to do so may result in the holiday being cancelled and cancellations charges outlined below would be effective.

## Changing your Golf Package

If you wish to make changes to your golf package you must be prepared to pay the additional costs, if any, involved. Golfing in Brittany will at all times endeavour to accommodate your requests at minimum cost. After changes have been made a new invoice will be issued.

## Cancelling your Golf Package

If you need to cancel your golf package you must notify Golfing in Brittany in writing or by fax. The cancellation date will be the date on which Golf in Brittany receives written notification. The following cancellation charges will apply.

41 to 29 days	30% of total cost
28 to 14 days	60% of total cost
14 to 7 days	75% of total cost
7 days to 48 hours	90% of total cost
Less than 48 hours	100% of total cost

## Complaints

If you encounter a problem with any aspect of your holiday you must notify the provider (hotel, golf course etc.) immediately to enable him to rectify the problem. If you are unable to obtain satisfaction you must notify Golfing in Brittany by fax or phone. If in spite of our best efforts we are unable to resolve the problem you must notify us in writing within 28 days of your return. We cannot accept responsibility if you fail to follow this simple procedure.

## Our Commitment to You Changes to your Holiday

If we make a significant change to your golf package (change of port to a less convenient one, change of scheduled

departure time by more than 9 hours, change of more than 2 golf courses) you will be notified as soon as we are aware. Should you wish to cancel at that stage there would be a 100% refund.

Minor changes such as tee times, small departure time changes, twin instead of double room etc., must be considered in the context of the overall holiday and the number of different suppliers upon whom Golf in Brittany is dependent in order to provide a golfing holiday.

## If We Cancel Your Holiday

There will be 100% refund of all monies paid. If the cancellation takes place within 42 days of departure, Golf in Brittany will undertake to provide an acceptable alternative. Should we fail in this endeavour we will provide compensation up to a maximum of £50 per person or 10% of the total holiday cost whichever is the lower.

## Our Responsibility for your Holiday

Golf in Brittany will endeavour to provide the holiday as booked. Should our agents, suppliers, or we fail to provide the promised service then Golf in Brittany accepts overall responsibility provided that the complaint procedure above has been followed. Exceptions are damage to personal possessions in transit and late arrival at ports, airports or golf courses. Also when antisocial behaviour precludes our agent from wishing to provide a service (ie. for being drunk or abusive).

## Arbitration

Should we fail to resolve amicably and dispute arising from this contract you may take the case to arbitration. This is an inexpensive procedure provided by the Chartered Institute of Arbitrators.

## Other Important Information Delays

Golfing in Brittany cannot accept responsibility for delays and associated costs of delay by an airline or ferry company. The travel insurance policy provides compensation for significant delays and curtailment.

## Accommodation

While we endeavour to provide the very best for our clients we cannot be held responsible for a poor view, twin beds instead of double, unless such request has been made at the time of booking and made clear that it is a condition of booking.

## Car Hire

All car hire provided by Golfing in Brittany is on condition that the driver is over 24 years old, has a clean, internationally recognised, driving license and agrees to return the car to the agreed drop-off point. Petrol costs are not included.

## Golf Arrangements

We do not invoice a holiday until your tee times have been reserved to your satisfaction. These will be confirmed on the invoice. No tee times will be reserved until deposits have been paid. Should tee times and courses change we will endeavour to ensure your satisfaction but it must be understood that in some cases courses would be closed at short notice. Should more than 2 of your courses be changed we would consider that a major change to your holiday and you would be offered a chance to cancel without loss.

## Financial Protection

The Travel Trust Association Ltd. is a trade association of Travel Agents, Tour Operators and Travel Organisers, that operate trust accounts, in order to provide financial protection for the consumer.

## Insurance

Due to recent government legislation Golfing in Brittany is no longer permitted to provide insurance cover, including annual cover. However, we are able to introduce you to a supplier of comprehensive travel insurance. If you wish to use this facility then chose one of the following:

If you decide not to use the insurance facility offered we understand that you have your own adequate cover for personal accident, medical expenses and 3rd party insurance. Golfing in Brittany will not be responsible should you travel without insurance.
